CHEETAH PALM BEACH

Membership Rules and Regulations

I hereby apply for membership to the private club known as "CHEETAH PALM BEACH" in West Palm Beach, Florida. I agree that this is a preliminary/temporary membership and is subject to approval by a membership committee. Violation of any of the following rules specified herein shall result in immediate expulsion from the club, revocation of any membership, and that I shall be forever barred from seeking membership in the future.

CHEETAH PALM BEACH is a private club, which requires submission of a membership application and approval by a membership committee. This is not open to the public. A prerequisite to membership is that all applicants and members share the belief that nudity is a natural and beautiful expression of one's First Amendment rights and that club members choose to participate in this environment similar to attending nudist camp. The activities, which occur at this private club, members who have agreed to abide by membership rules while on the premises exercise their rights of freedom of speech, association and privacy.

CHEETAH PALM BEACH is licensed to sell alcoholic beverages only to members who voluntarily enter the licensed establishment as a private club. Members of this private club perform exotic dancing, which occurs within CHEETAH PALM BEACH. CHEETAH PALM BEACH makes no payment to the performers. The performances presented at the CHEETAH PALM BEACH are protected expressions pursuant to the First Amendment of the United States Constitution and pursuant to Article I, Section 23 of the Florida Constitution. These activities include the display or exposure of nudity amongst club members in the exercise of their rights to freedom of speech, expression and privacy.

Membership dues to the club cost \$300.00 ANNUALLY. The dues can be paid in the following manner with cash or credit cards:

All payments are applied to the member's annual membership fee. Membership fees are utilized for the operational costs. Each member of the club acknowledges that all other club members have an individual right to privacy and that names or identities of any club member are private and confidential. Members confess that should they violate the right of privacy of any member by exposing any member to public scrutiny, unwanted publicity, or recognition in any publication or public forum they will be liable for one million dollars (1,000,000.00) in liquidated damages for violation of said right of privacy. Each member has his individual right to privacy and the one million dollar judgment is a specific quantification of the enormous value of this right that each club member retains. Should anybody attempt to obtain a membership for any other reason other than to enter the club facilities, then that member or law enforcement officer or agency expressly waives any and all rights to immunity which may otherwise exist under Florida or Federal law. Should said violation of privacy occur the perpetrator(s) of this violation of privacy shall be liable for one million dollars (\$1,000,000.00). The person or entity being sued acknowledges they may be sued individually as well as in their official capacity and that they will be individually responsible for a judgment, that they waive any and all homestead rights and any and all

privileges that may otherwise exist under law. All members are encouraged to attend club meetings.

I agree:

1. That I am above the age of (25), that I have furnished valid proof of my birth date i.e., birth certificate, driver's license, passport, as proof that I am over (25) years of age and consent to;
2. To pay all Annual membership dues of \$300.00, that maybe payable during a one year period at the member's attendance at the club;
3. That I am financially able to pay membership dues;
4. I have no prior or current membership in a subversive, racial or organization known to be violent;
5. I have not had other private club memberships terminated;
6. I am willing to participate in club activities and may participate in club committees and attend club meetings;
7. Not to bring any alcoholic beverages or illegal substances into the club;
8. Not to bring any firearms, weapons or other destructive devices in to the club;
9. Not to engage in prostitution or the solicitation, inducement, enticement or procurement of another to commit prostitution or other illegal acts of any kind or nature;
10. Not to disseminate or publish the names, addresses, or telephone numbers of any other club members or to use such information in any way, shape or manner without first obtaining the written consent of the club, member and the written consent of the management for Cheetah Palm Beach;
11. Not to bring a camera, listening device or any other recording device into the club;
12. That members of the private club may dance under strict supervision of the club personnel;
13. To consent to the behavior and activities which I understand shall occur at the Cheetah Palm Beach;
14. To obey any and all rules of the club;
15. I have a belief and conviction that membership in the club is an expression of the freedom of belief in the right to exhibit the nude body and consent to this expression of freedom of belief in my presence.

Any violation of the rules will result in the expulsion from the club and may result in termination of club membership.

I am a firm believer in the First Amendment of the United States Constitution. Similarly, I desire to exercise my right to privacy pursuant to article I. Section 23 of the Florida Constitution. I am entering the Cheetah Palm Beach freely, knowingly, voluntarily and on my own volition. I understand the Cheetah Palm Beach is a private non-profit club incorporated under the laws of Florida as 3342 Social Club Corp. I understand the types of activities and behavior, which occur in Cheetah Palm Beach and agree to abide by the rules and regulations of the club, which I have read and understand.
